**FAMILY MEMBERSHIPS** allow family members living in the same household daily use of the facilities during normal operating hours. Use of the facility outside of normal operating hours is allowed if involved in other activities such as swim team practices or tennis lessons. Use applies for that part of the facility directly related to the activity for which they are signed up and only under supervision of designated coaches or other persons involved with running that activity.

**ADULT INDIVIDUAL and SENIOR MEMBERSHIPS** allow for use as stated above.

**YOUTH LIMITED INDIVIDUAL MEMBERSHIP** allows for use as stated above, however, **YOUTH MEMBERSHIPS** are not entitled to Guest Privileges.

**TRIAL MEMBERSHIPS** allow for use of the facility as stated above for the first year (one time only) at a reduced cost for the member to get a feel for the club in order to decide if they want to become a continuing member. If so, normal fees apply the second year.

**SWIM TEAM REGISTRATION** – Please check the web site for information about swim team registration, fees, fundraisers, etc.

**GUEST POLICIES AND FEES:**

**The guest policies and fees listed below will be in effect for the 2012 season.**

A guest is defined as anyone who is invited by a member to use any of the pool facilities.

**A guest is a person residing at a different home address.**

1. All guests must sign in at the front desk before entering the pool area and must be accompanied by a member at all times.
2. Local guests will be limited to 5 visits per season.
3. Guest fees must be paid any day that the club is open.
4. All guests 12 and under must be immediately introduced to the pool manager or lifeguard in charge and complete a swimming test.
5. Rain checks will be issued to members for their guests if the pool is closed due to sudden inclement weather. Rain checks must be used during the current season. There will be no refunds.
6. Guests not using the pool, tennis, or basketball courts will not be charged a fee.

**GUEST FEES:** Daily \$5.00 for each guest 4 years of age and older.

**MULTI-PASS GUEST PASSES:** 10 pass card for \$40.00

Guest passes are good ANY day and are non-transferable and can be carried over to the next pool season.

Grandparents (not using pool)..... No Charge

There is no charge for entering facilities for observing swim meets.

### **BABYSITTER PASS**

Stones Crossing Swim Club must be notified in writing as to who will be using this pass, and for approximately how long (days/weeks).

Babysitters of Club members must be at least fifteen years of age to care for the children of other Club members. We strongly recommend having a certificate of babysitters course if under seventeen years of age.

Members and babysitters MUST adhere to all pool rules and the following, particularly #2:

1. All emergency information for each child must be on file in the office.
2. Babysitter must be continually attentive to and responsible for the child or children in their charge while on the Club's property.
3. Babysitter cannot bring guests into the Club.
4. Babysitter cannot use the Club when not caring for children nor when child's parent or guardian is present at the Club.

False information or unintended use of this pass will result in the pass being revoked and/or membership at the pool revoked with no fees refunded.

### **OPERATING SCHEDULE**

Stones Crossing Swimming Club is typically opened Memorial Day weekend through Labor Day, 12-8pm. Depending on school year schedules, this may be adjusted slightly. The Club reserves the right to adjust operating hours, modify rules and policies, or close the pool for inclement weather (forecasted or actual), swim team events, and at other times deemed necessary. All swim meets, private parties, and other events are typically posted at least 2 weeks in advance.

### **STONES CROSSING SWIM CLUB COMMUNICATIONS**

It is the intention of the Club's Board of Directors to provide regular monthly communications regarding schedule changes and other items of interest, using the email address provided at time of registration. These communications will also be posted on the Club's bulletin board.
